

COMMITMENT LETTER

The Eleventh Edition of the United Nations Model of the National Mexican Congress Model UN, CONGRESMUN 2018.

In order to comply with the provisions of the Rules of Procedure of CONGRESMUN XI, those who subscribe commit themselves to:

- I. Respect the furniture of the chamber;
- II. Follow the directions that are issued on security by the authorities of the Congress or, by the CONGRESMUN Secretariat;
- III. Maintain a behaviour that conforms to the solemnity of the headquarters;
- IV. Appropriately address any person within the premises of the chamber;
- V. Respect the dress code established in the Rules of Procedure, remembering that it MUST be formal;
- VI. Carry at all times the identification badge that will allow the participant to enter, remain and leave the premises;
- VII. Attend all work sessions, as well as their correct academic preparation.

Important Notes:

- 1. The carrying and consumption of alcohol, drugs and/or narcotic substances and/or psychoactive substances that alter the state of conscience and/or act against your health or that of your companions are STRICTLY PROHIBITED.
- 2. It is also STRICTLY PROHIBITED the carrying and use of firearms, explosive devices and/or other devices that represent a danger or harmful threat to you and/or other people.
- 3. The dress codes must comply with the following characteristics:
 - a. The clothing for men must adhere to the following:
 - a) They must dress in a suit or dress pants with sweater and/or jacket, shirt, tie and formal shoes.
 - b) The use of: denim or baggy pants (cargo type), ties with children's themes and tennis shoes are strictly prohibited.
 - a. Women's clothing must meet the following standards:
 - a) They must wear a formal suit or blouse, dress pants or skirt, sweater or coat, and formal shoes;
 - b) The use of dress will be allowed, as long as it is formal. The use of a formal jacket will be tolerated. Skirts and dresses should be no less than 4 inches above the knee and should be accompanied by plain stockings.
 - c) The use of strapless dresses or blouses or tank tops is not allowed.
 - d) The use of blouses or dresses with a pronounced neckline, miniskirts, shorts or tennis is strictly prohibited.



- 4. During the stay of the participant in the Legislative Palace of San Lazaro, it will be forbidden to access buildings or restricted areas. You will not be able, for any reason, to wander around the headquarters. Likewise, yards, common areas, corridors and exteriors, will have to be respected in the same way as the rooms where the Committees are simulated.
- 5. The participant should always maintain a diplomatic posture, even outside sessions; shouting, inappropriate language or any other situation that disrupts the order and cause discrepancies with the authorities of the enclosure will not be accepted.
- 6. The participant must fulfil one hundred percent attendance in the work sessions; the Board will proceed with a sanction against any unjustified absence.
- 7. Any failure to comply with the internal regulations of the Congress or CONGRESMUN shall mean the definitive expulsion from the Conference and the enclosure.

Order and the fulfilment of the rules established in this commitment letter and in the Rules of Procedure will be maintained, in case of its non-compliance, a solution or sanction will be considered by the Secretariat, or, if applicable, will be sent to the authorities.

Any unforeseen situations will be solved by the Conference Secretariat together with the Unit of International Affairs and Parliamentary Relations of the Chamber of Deputies.
